## **Duties & Responsibilities:**

The primary function of this position is to provide meaningful, personalized support to individuals in their own residences in the community. The successful applicant will be supporting individuals in the community with life skills, recreation and socialization. **Use of own vehicle will be required for this position.**

- Extreme flexibility required for this position.
- Experience and knowledge around mental health and addictions an asset.
- Must have previous experience and/or relevant education in working with people with developmental disabilities in a community setting.
- Must be able to demonstrate an understanding of the goals of the Independent Living Service and be able to identify ways in which these can be fostered in working with individuals with developmental disabilities in community-based settings.
- Must be able to demonstrate a sound philosophical understanding of the principles of social role normalization and integration.
- A positive and pleasant work attitude and the abilities to participate as an active team member, communicate effectively with parents, advocates, individuals, and co-workers are essential.
- Must be prepared to be flexible, work varying shifts.
- Proficient in the use of computer including use of Gmail & Microsoft Office.
- Must have CPI training.
- Must meet all other CSCL hiring requirements (First Aid, Medical Certificate etc.)

## **Special Qualifications:**

Class IV needed for this position, as applicant must drive modified van.

## Shifts/Schedule:

Monday - Friday, 9am - 5pm

(40 hours per week.)

#### Compensation:
