Duties & Responsibilities:

The primary function of this position is to provide meaningful, personalized support to an individual in their home and community.

Note: There will be another staff member that the successful candidate will be working with at all times.

Qualifications & Experience:

- Must have training and experience in working with persons with complex behavior, health care needs and mental health.
- Must have demonstrated skills in the area of positive behavioral support.
- Must be physically able to meet the demands of the job.
- A positive and pleasant work attitude, effective communication skills and a solid understanding of consistent work practices are essential.
- This position will require continued training and working closely with external professionals.
- Must possess a Class 5 Driver's License and a reliable vehicle, First Aid/CPR Certification, Caring About Food Safety, and be able to meet all other CSCL employment criteria (i.e. Criminal Record Check clearance, Doctor's Certificate of Good Health, etc.)

Special Qualifications:

- Experience working with mental health individuals.
- Some administration skills needed.
- Able to prepare and cook meals.

Shifts/Schedule:

Float Position - Must be flexible and available for all day, afternoon, and weekend shifts. (Wake over availability is required.)

Shifts will vary to meet the requirements of the service; schedule flexibility is required.

Hours per week are posted 2 weeks ahead as per collective agreement.

(24 hours per week.)

Compensation:

As per Community Social Services Collective Agreement (\$19.45 - \$22.65 per hour).

Benefits include Extended Health and Dental, as well as participation in the Municipal Pension Plan, when eligible.

This position requires Union membership (BCGEU).
